Determine the structural organization of the Internal Security Forces

The President of the Republic.

Based on the Constitution.

Based on Law No. 17 date 6/9/1990 (organizing internal security forces) in particular Article 7th of it.

At the suggestion of Interior Minister.

The opinion poll Command Council in the internal security forces.

After consulting the State Consultative Council (Opinion No. 49, dated 20 Feb. 1991).

After approval by the Council of Ministers at its meeting on 20/3/1991.

Decides that:

Part One

The General Organization of the structural of internal security forces

Chapter 1

The command of the internal security forces

Article 1:

The following words mean, wherever contained in this Decree as mentioned against each of them:

- Minister: Minister of the Interior.

- Director General: Director General of Internal Security Forces.

- Inspector General: Inspector General of Internal Security Forces.
- General Directorate: Directorate General of Internal Security Forces.
- Inspection General: General Inspectorate of the Internal Security Forces
- Police: regional police.
- Structure: security service departments, embassies and public institutions.
- Institute: Institute of Internal Security Forces.
- Units: the different units and formations of the internal security forces.
- Regulation Act Security Forces: Law No. 17 of 6 / 9 / 1990 (organizing internal security forces).

Article 2: Command of the Internal Security Forces:

The structural of command in internal security forces, as stipulated in Article 5 of the Act of regulating internal security forces are:

- The Directorate General of the Director General and Chief of Staff and the central administration.
- General Inspection.
- Regional police command.
- Walking force command.
- Police headquarters in Beirut.
- The command of the judicial police.
- Command Security Service embassies, departments and public institutions.
- Command Institute of Internal Security Forces.
- Presidency of social services.
- Command Council.

Article 3: Links between leaders and heads of command:

Except the Inspector General, which is directly linked to the minister, is linked to both the leaders and heads of security structural of the Internal Security Forces Director General, under the direct authority, and each of them is accountable for tasks related to him and taking into account the provisions of the second paragraph of Article 17th of the Law on Organization of Security Forces Procedure imposed on the Judicial Police Commander exclusively from the rest of unit commanders to be accountable to both of:

- General Director: With regard to the implementation of properties assigned to it from an administrative and telecommunications equipment on the survey, control and professional matters aimed at supporting units.
- Attorney General discriminatory. Talk With the implementation of tasks relating to the judicial units belong to him, and thus does not affect his submission to the authority of the Director-General

Chapter II: The leaders of the functions of the structural command

Article 4.: Functions of the Director-General:

That the functions of the Director General of specific detail in the law organizing internal security forces in the rest of legal and regulatory texts in force.

Article 5: The functions of all the leaders of devices:

The tasks of the rest of the leaders of specific law on organizing internal security forces in the following sections of this Decree and the rest of the regulatory texts in force.

Article 6: The provisions of the joint heads of unit commanders of various ranks:

Is contingent commanders and heads of functions specified for each of them in Decree and have them as a result of exercising these shed involving tasks are:

- Management and command of their units, and urged them to work with securing the necessary coordination among them and ensure their survival eligible for the implementation of the tasks associated with them.
- Monitoring the implementation of services for the group and taking care without deviation subordinates on the implementation of core functions.
- Implementation of the direct orders of their superiors in accordance with the laws and regulations in force with immediate benefit for every flaw or mistake important verified.
- Verification of non-interference by subordinates in their relations with citizens and political matters of local disputes.
- Overseeing the upbringing of their subordinates, both moral and

behavioral development with good qualities and good qualities in them and inspire the spirit of sympathy and a sense of duty and responsibilities and show honesty and loyalty and sacrifice for the homeland.

- Carefully selecting members qualified to assume the responsibilities and important positions.
- Maintaining strict discipline and just at the same time, with the need to ensure the imposition of sanctions and grant appropriate rewards with fairness.
- Caring for buildings, equipment, supplies and equipment designed disposal units for them.

Part One

GENERAL STAFF

Chapter I The organization of General Staff

Article 7: Organization of Staff:

Staff includes the following units:

- Accouterments Division (Division of Special Affairs).
- Division of service and operations
- Division of Management.
- Division of Planning and Management
- Division of the investigation and inspection.
- Public Relations Division.
- Training Division
- International Communications Division.
- Division of informatics.
- Division of Post and archives.
- Clerk Director-General
- Internal Security Forces personnel.

Article 8: The Organization of the people of Staff:

The head of each division of the Staff Officer Commander at least directly under the authority of the Chief of Staff assisted by the Nos. of officers in each division depending on the importance and volume of work in the same division.

The regulation adopted for the people of Staff is shown in the following paragraphs of this should have been divided each division

to an officer except for the security of Information Branch of the Division of Public Relations can preside over a civilian employee or contractor who are holding a degree in the media:

H - Division of the International Contact branch of Interpol

J - Division of Post and archives include:

- Mail Branch.

Can retail affiliates of each of these people into several sections, each of which is headed by an officer or sergeant with the rank of sergeant first at least.

Article 9: - Organizing Director General Clerk:

The head clerk Director General officer directly under the authority of the Chief of Staff clerk consists of:

A - the presidency of the clerk and include:

- Chairman of the clerk assisted Nos. of sergeants and

noncommissioned officers

B - A group's headquarters and includes:

- General Command Headquarters Group and led by officers directly under the authority of the Head of the clerk officer assisted by a group called the Assistant Commander of the general headquarters
- Command offices, namely:
 - Office of the Accouterments and training.
 - Office of command.
 - Post Office.
- A group that includes all factions, including Nos. of noncommissioned officers .

The head of each of these offices and factions officer. As noncommissioned officers each of which holds the presidency of sergeant.

Article 10:. Music organizing internal security forces:

The command staff of the Internal Security Forces Commander officer assisted Nos. of officers is composed of musicians:

A- The command of music and includes:

- Many office and training.
- Office of Administration.
- Depot.

B - A group trumpets and drums.

Chapter II

– Staff

Article 11: functions of the Chief of Staff.

The Chief of Staff Assistant Director-General in implementing the tasks related, through:

- Management Groups of Staff urged them to work.
- Prepare resolutions after the Director General to provide him with all the facts to enable the latter to assess the situation and take the appropriate decision.
- Director-General circulates decisions and putting them into effect.
- Follow the implementation of tasks related to the internal security forces, in accordance with applicable laws and regulations.
- The signing of issuing orders and transactions that do not affect the principles of management and service and those that do not lead to

the convening of the expenses not originally included in the administrative authorities delegated by the Director-General.

Article 12: - Issue tasks Division (Division of Special Affairs)

This Division takes care of Special Affairs of all workers in the internal security forces, including reservists and retirees, except those relating to their financial affairs, health and social. These affairs are to name but are not exclusively:

- Recruitment, adaptation and renewal of contracts volunteer .
- Demobilization and stop the demobilization terminating volunteering contracts.
- Appointment of changing centers and use.
- Promotions.
- Changing conditions
- Intimations and rewards.
- Marriage
- Behavioral and judicial proceedings
- Public reservists and contractors.

This Division is also takes care of files of all workers in the internal security forces in addition to the keeping of Command Council resolutions, according to what is mentioned under Article 19th of the Act regulating internal security forces.

Article 13: - Division of service functions and operations:

Interested in using this division of power and information collection and invested in accordance with the following

A- In-service use:

- Preparation of orders relating to the implementation of the policy of the Directorate General, in everything related to the functions of internal security forces, particularly in terms of:
 - Consolidation of security and maintaining order.
 - Guarding the prisons, institutions and public administrations.
 - Securing an officer walking and as defined in Article 232 of the Act regulating internal security forces.
 - Provide support to the authorities.
 - Inform the authorities and the relevant authorities about the incidents that are informed or those that expected from happening.
 - Liaison with relevant authorities, especially the leaders of the armed forces, both in relation to the affairs of the service and information.

- Circulating orders and instructions on security measures should be taken in certain circumstances.
- Submit proposals to improve production, including the proposal to develop units and determine their authorities .
- Ensure coordination between the various activities of units, especially their operations and to this end, arise in this division operations room believes in direct and immediate contacts with all units.
- Identify key points and vital custody or control required.
- Estimate the annual need of men of the Internal Security Forces Reserve in preparation for their willingness to accept or resumption of active service in accordance with the applicable assets.
- Investment statistics on the affairs of the service.

B - (amended by Decree No. 3904 of 6 / August, 1993)

In the area of information:

- Determine the quality of information which considers the Directorate General collected and providing the necessary prelude to investing.
- Give information that could be used by units and that as quickly as possible.
- The task of survey information relating to security and military discipline of the components of the internal security forces, working in the forces and monitor their actions and behavior in and outside the service and information related to the safety and security of the barracks, buildings and various types of gear and equipment owned and invested, investigation and prosecution of perpetrators and aggressors in accordance with the applicable legal principles.
- If necessary coordination with other security agencies use different affairs and information exchange.
- Processing section is the technical means that are necessary in the fields of communications and information storage.
- This task is determined by the Director General's instructions and internal security forces.

Article 14: the functions of the Division of Administration:

this Division is Interested in all administrative and financial responsibilities regarding internal security forces and personnel of these forces is concerned, assisted by the Director General to take administrative decisions in accordance with the provisions of

applicable laws and regulations.

Article 15: the functions of the Planning and Management Division:

This Division is interested in putting plans that lead to the development of the internal security forces and is charged in particular:

- Preparing the draft texts of legal, regulatory and work to develop what is applied them.
- Preparation of projects concerning the Accouterments of installed internal security forces.
- Choose the means and methods of work required adoption of the internal security forces.
- Examine the appropriate rules for the use and absorb modern technology.
- The development of studies and research determined by the Director General and Chief of Staff.
- Department of Public authentication of the Internal Security Forces and the provision of textbooks and reference for various activities of units and organizing ways to benefit from them.

Article 16: the functions of the Investigation Division and Inspection:

this Division is Interested in to conduct periodic inspections and investigate the sudden determined by the Director-General also interested in scrutinizing inspection reports received from the Inspector General and the rest of the processor units with the competent departments, and make appropriate proposals on them.

Article 17: Public Relations Division of tasks:

this Division is interested in to implement the policy in each Directorate-General with regard to public relations and is costly in particular:

- Directing the internal security men forces and raising their morale.
- Development of the relationship between internal security forces and media.
- Closer relationship between the men of the internal security forces and citizens.
- Make and directing and guiding citizens to urge them to participate automatically in the fight against crime and help support the men and

internal security forces in carrying out the tasks related to them.

- Provide the media in everything related to the activities of internal security forces, according to clearance by the laws and regulations.
- Follow-up transactions involved in internal security forces in official circles as determined by the Director-General.
- Organizing ceremonies and receptions own internal security forces.
- Exhibitions of private security
- Coordination of personal interviews and carry out the tasks specified by the Director General and Chief of Staff and his associates in various matters relating to each office member.

Article 18: - Training Division functions:

This Division is interested in the affairs of men training and rehabilitating the internal security forces and raise their standard of behavior and cultural interest in a particular:

- Drawing the general policy of preparation and training
- A public perception of the program of training and education
- Identification schemes and training courses inside and outside the country
- Further development of educational methods and modern training.
- Work to ensure staffing in the Educational and Training Institute.
- Conduct Exercise imposed on the members of groups of Staff and German sports specific to them.

Article 19: The functions of the Division of the International Contact:

this Division is interested in would have contact with institutions and Arab and international organizations, especially the Permanent Council of Arab Interior Ministers and Arab organizations. The International Criminal Police Organization - Interpol - and the rest of bodies and structural police and security, and focuses on addressing matters arising from this communication.

Article 2: IT Division functions:

this Division is interested in management mechanization of the Internal Security Forces and the development of tools and investment information and its relationship with the disposal units as soon possible way, as well as the preparation of statistics and invested according to modern methods.

Article 21: The functions of the Division of Post and archives:

This Division is interested in receiving General Directorate and registration, distribution and conservation of its keepers and in accordance with regulations in place.

Article 22: Functions clerk behind General:

Director-General clerk who was interested in the following tasks:

- Coordinate the dates and interviews Director-General.
- Liaise with the figures determined by the Director-General.
- Support the Director-General in various subjects by virtue of his office.

The functions of the Group's headquarter is directly linked to the author of the Director-General concerned with the following:

- Guarding the headquarters of the Directorate General of its units while maintaining its assets.
- Protect and keep pace with the Director-General guarding places of residence.
- Perform ceremonies honor determined by the Director-General.
- Implementation of interviews and reviews owners Interests at the headquarters of the Directorate General in accordance with the instructions of the Director-General.

Article 23: Music functions of the Internal Security Forces:

Interested in music, the internal security forces to perform ceremonies and honor and conduct ceremonies determined by the Director-General.

Part III

Central management organization of the first quarter of central administration

Article 24 : Organizing the central administration:

Central administration consists of:

A. Presidency of the central administration and includes

- Chairman of the Central Administration assisted by two officers designated first Assistant and second Assistant to the head of the central administration.
- Branches of command, namely:
 - Budget Branch.
 - Maintenance Branch.

- Accouterments Branch.
- Administration Branch.
- Training Branch.
- Mail Branch.

B - Eight interests are:

- The interest of the buildings.
- Health Service.
- The interest of communication.
- Mechanisms interest.
- The interest of arms and ammunition.
- Supplies Interest.
- Processing Interest.
- Financial interest.

Article 25: branches of the organization command:

The head of each of the branches of command in the presidency of the central administration officer, except postal branch, which could be chaired by the mood and subject each of them the direct authority of the first assistant to the head of the Central Administration.

Indivisible each of these branches into several sections each of which is headed by an officer or sergeant with the rank of sergeant first, at least directly under the authority of the Head of the branch.

Article 26: - organizing the interests of central administration:

The head of each of the interests of the central administration officer, the commander directly under the authority of the Head of the central administration. The regulation adopted each of them is shown in the following paragraphs of this Article should have been indivisible every interest to several offices, will head the office of the officer under the direct authority of the Head of interest:

A. The interest of buildings:

- Administrative office
- Office of lessons.
- Office contracts.
- Office of receipt.
- Works Affairs Office.
- Maintenance of a central office.
- Maintenance of sub-offices
- Office of cash purchases.

- Depots Office.
- Post Office.

B. Department of Health and includes:

- Administrative office.
- A central medical centre.
- Medical centers subsidiary.
- Central pharmacy.
- Pharmacies subsidiary.
- Office of cash purchases.
- Office of medicines and medical supplies.
- Post Office.

C - The interest of communication and includes:

- Administrative office.
- Office of art.
- Central concerns.
- Concerns of a subsidiary.
- Office of cash purchases.
- Depots Office.
- Post Office.

D - Interest mechanisms and add:

- Administrative office.
- Office of art.
- A central garage.
- Know garage.
- Office of cash purchases.
- Depots Office.
- Post Office.

E - The interest of arms, ammunition and includes

- Administrative office.
- Office of art.
- Central concerns.
- Concerns of a subsidiary.
- Office of cash purchases.
- Office depots.

- Post Office.
- And - The interest of supplies
- Administrative office.
- Office of art.
- Central concerns.
- Concerns of a subsidiary.
- Office of cash purchases.
- Office depots.
- Post Office.

H. Processing includes interest:

- Office contracts.
- Office of receipt.
- Depots Office.
- Post Office.

I - Financial interest include:

- Loan Office
- Holding office expenses.
- Office of liquidation expenses.
- Office of salaries and allowances and assistance.
- Post Office.

Chapter II

The functions of the central administration

Article 27: - Chairman of the functions of the central administration:

Due to that the Head is taking over the command of the central administration sets out a specialized management and accounting and finance functions is unique and special responsibilities defined in detail in the management system stipulated in Article 183 of the Act regulating internal security forces. However, in general, he rules the units by the Department of accouterments, equipment and supplies and buildings belonging to the internal security forces, with subsequent work for this, especially:

1 - Prepare the draft annual budget and then develop a program implemented after the approval.

2 - Develop programs to achieve accouterments, equipment and

supplies and works on buildings belonging to the internal security forces and set their disposal.

3 - Storage, distribution, maintenance and removal of equipment and materiel, supplies and maintenance of accounting entries the accounting provisions for the internal security forces and prisons.

4 - To secure payment of salaries and allowances and assistance belonging to different workers in the internal security forces.

5 - Prepare draft of resolutions and administrative provisions necessary to secure booking expenses for the internal security forces and the liquidation of all of these expenses.

6 - To secure the men deal with the internal security forces, including retirees, including members of his family as well as convicted prisoners and detainees.

7 - Propose methods of work in the administrative units.

8 - Doing all the work of central management in accordance with due to regulations process enforced, which enjoys authorities in this regard specifically in administrative and financial director of the public administrations, and can be regarded as Chairman of a specialized unit with respect to holding expenses to achieve buy equipment and materiel, supplies and construction of buildings and provision of services under different statement or invoice.

Article 28: assistants to the Head of the functions of the central administration:

The functions of assistant head of the Central Administration as follows:

A - First Assistant functions:

- Acting as head of the Central Administration in the case of interruption in service oh this latest one for any reason, exercised in this case all the functions and authorities of the Head optimal except subscription membership of the Board of command in internal security forces.

- Manages sections of the Presidency of the central administration and urges them to work and secures the necessary coordination

among them.

- Shows his view of all transactions that raise by the head of the Central Administration.

B – Tasks of the second Assistant:

- Acting as first assistant in the latter case of a break in service for any reason, exercised in this case all the functions and authorities .

- Chairman of the Central Administration helps everything related to the tasks assigned to the central administration and other functions within First Assistant.

- The investigations and inspections assigned by the Head of the central administration and working groups relating to the affairs of the Department and the rest of the tasks specified by him personally.

Article 29: branches of the functions of command:

Branch interested in balancing the budget in all of the internal security forces, and concerned branch maintenance matters relating to the maintenance of all equipment, supplies, equipment and buildings belonging to the internal security forces or set their disposal.

The functions of the rest of the branches of command are similar to those of the people of Staff matching names with the designations of these branches are laid out in Articles twelfth and fourteenth and eighteenth and 21 of this Decree.

Article 30: Good functions of the central administration:

Except financial interest, concerned with both the interests of the central administration, according to the nomination of their respective development of technical studies on the needs of internal security forces is entrusted with the management to prepare the draft annual Budget in every respect of these things achieved and with the insurance receipt, storage, in accordance with regulations in force E as well as securing control Art in everything related to maintenance work and prepare procurement transactions conducted in a statement or invoice.

The financial interest is generally concerned with the maintenance of accounting allocations for the internal security forces and preparing requests for booking and propose the transfer of credits and loans repaid and the proposed transfer and recycling credits and the preparation of salary scales and compensation and assistance and payment orders issued returning them, and everything related to the

management of funds belonging to the internal security forces.

Part IV

Public inspection

Chapter I Organizing public inspection

Article 31:. Organizing public inspection

General inspection consisted of:

A - Mufti General Officer Commander assisted by at least called the Assistant Inspector General.

B - Branches of command are:

- complaints and inspections Branch.
- Accouterments and training Branch.
- Administration Branch.
- Mail Branch.
- Department of Human Rights

C - Section of complaints and investigations.

D. Inspections Section.

Article 32: - organize branches of command:

Organize branches of command in general inspection organization along the lines adopted for the command of the branches of the central administration as set out in Article 25 of this Decree.

Article 33: - Organization of complaints and investigations section:

The head of department of complaints and investigations Commander is an officer of at least directly under the authority of the Inspector General is assisted by Nos. of officers and sergeants and noncommissioned officers .

Article 34: - Inspection Section of the organization:

The head of the inspection Commander is an officer at least directly ordered by the authority of the Inspector General is assisted by Nos. of officers inspectors.

Article 43 bis - organization of Human rights:

The Department of Human Rights is headed by at least a Senior officer, answering directly to the Inspector General, and is assisted by a number of officers, NCOs and privates.

Chapter II

General inspection functions groups

Article 35: General Inspection functions:

The tasks of the Inspector General Act in specific detail the organization of internal security forces, however, to give inspections and inspections by the inspectors more effectively as possible requests:

- Stay in close contact with the Director-General.
- Inform the Director-General on important issues that achieved during a visit or tour inspectors sets him on the internal security forces, and deliberated upon without leading to any switch in the course of reports that he submits to the minister and the Director General in this regard briefed the Inspector General's objectives and policy General Directorate in various fields within its competence as well as overcome the difficulties imposed to achieve these goals.

Article 36: Assistant tasks of General Inspector

Assistant Inspector General is ordered by the direct authority of the Inspector General, and is liable to cope with the tasks specified by him as he represented the Inspector General in the case of this latest one is interrupted the service for any reason, exercised in this case, for the duration of the absence of the Inspector General of all his functions and authorities except for a membership subscription Command Council Of the internal security forces.

Article 37: Branches of command functions:

Branch is interested in complaints and inspections of all matters relating to complaints and news contained to public inspection as well as inspection, which is an inspection by the General

Inspectorate.

The functions of the other branches command are similar to those of the people of Staff matching names with the designations of these branches stipulated in Articles 11 and a 3 and 17 of this Decree.

Article 31: Functions of complaints and investigations section:

Limited functions of this section and news complaints received by the General Inspectorate, to conduct the necessary investigations on them.

Article 39: Section inspection tasks:

The functions of this section shall:

- Conduct inspections of all groups of internal security forces, taking into account the provisions of Article 3 of the Act regulating block internal security forces.
- The development of studies on improving work in groups of internal security forces, in light of reports organized by the General Inspectorate officers.

In addition to the Inspector General, the inspections of these inspectors to settle by the Inspector General and exercising their functions in all Lebanese territory, in accordance with the orders and instructions to the Inspector General.

Article 39 bis – Tasks of the Human rights Division:

This Division undertakes the following tasks:

1. Defining The Human Rights within the Units of the Directorate General of Internal Security Forces.
2. Deepening the awareness of the personnel of the Directorate General of Internal Security Forces regarding Human Rights.
3. Protecting Human Rights in Lebanon from being abused by members of the concerned Units and taking the necessary measures to be applied.

4. Proposing to amend the laws and regulations that govern the work of the Internal Security Forces to be in line with Human Rights.
5. Educating, publishing and documenting all aspects of Human Rights.
6. Carrying out necessary studies and calling to organize scientific and practical sessions for all members of the ISF Directorate General concerned with applying Human Rights.
7. Giving necessary guidance on Human Rights to the concerned Units in the ISF Directorate General.
8. Coordinating with all local, regional and international civil and government associations in charge with Human Rights issues for a proper implementation by concerned Units in the ISF Directorate General.
9. Creating an electronic data base specific to the administration, on Human Rights in Lebanon.
10. Issuing bulletins on Human Rights and any other activity that serves Human Rights in Lebanon and distributing them on the concerned ISF Units.
11. Coordinating in this regard with the concerned Unit in the Directorate General of General Security.

Article 40: Various provisions:

A - determine the relationship between the Directorate General Assembly and Inspection Decree on the proposal of Minister of Interior building a proposal by the Director General and after taking the opinion of the Inspector General.

B - Define the rules work in groups of inspections under instructions issued by the Inspector General.

Article 41: Regional police organization:

Include the authorities of regional police unit all Lebanese territory except Beirut and includes all units operating outside Beirut, except those which are associated wholly or Partially to one of the units consisting of

a rule of the police and join:

- Chief of Police assisted by two officers designated Assistant I and II to the Chief Assistant of Police.

. Branch Command, namely:

- Accouterments Branch.

- Branch of service and operations and the operations room followed him.

- Administration Branch.

- training Branch.

- Branch Traffic.

- Prisons Branch.

- Mail Branch.

B - Regions: regulated as indicated in the Article / 43 / of this Decree.

Article 42: organize branches of command:

Except branch mail, which could be chaired by a sergeant, the presidency of both branches under the direct command officer to the authority of the first assistant to the commander of the police.

The regulation adopted for these branches is similar to the regulation

adopted for the people of Staff set forth in Article 8 of this Decree, to be launched Designation (Office) on both the local sections of each branch.

The head of each of these offices with the rank of sergeant first sergeant at least excluding the operations room of the branch of service and operations as ordered by an officer assisted by Nos. of officers and sergeants and noncommissioned officers.

Chapter II Regional Area

Article 43: Organization of the region:

The regional officer Area Command is a commander, at least directly under order by the authority of the police chief. The regional authorities include the principle of maintaining geographical scope and at least one is

A- Command of the region includes:

- Regional Area Command assisted by two officers designated Assistant I and II to the Assistant Commander of the region.
- Command offices, namely are:
 - Office of the Accouterments and training.
 - Office of service and operations and belonged to him the operations room and communications centre
 - Administrative office
 - Office of maintenance and includes Accouterments of substantive concerns.
 - Sport and Shooting and contacts Office.
 - Post Office.

B - Regional companies: organized according to what was stated in Article 45 of this Decree.

C - A central prisons group: With regard to the region located in the regional scope.

Reckonable exiled central prison.

D - A group of beaches: With regard to the region which borders with the Beach.

- Group Survey: working as one group.

Article 44: Command organization offices in the region:

The head of each office of the commander is under the direct command of the authority of the first assistant to the commander of the region except for the Post Office, which could be chaired by a

sergeant with the rank of sergeant first at least.

Indivisible each of these offices into several sections each section is headed by a sergeant with the rank of sergeant first at least the operations room of the branch of service and operations ordered by the commander assisted by Nos. of officers and sergeants and noncommissioned officers.

Article 45: Organization of the regional group:

The command of the regional group commander is ordered directly by the commander of the region. The regional authorities include, in principle, the geographical scope of several areas contiguous to one governorate is composed of:

A - The command group includes:

- Leader of the regional group is assisted by Assistant Commander-called leader of the group.
- Accouterments and training.
- Clerk of service and operations and tracking him operation room.
- Administrative clerk.
- Communications Center.

B. Regional factions: can work group or faction, indivisible each platoon to several regional stations.

C - A group functioning: working as one group.

D - A group of emergency: working as one

- Prison regional or regional prisons: As specified in the prison system.

Article 46: Regional Organization Platoon

The regional leaders platoon officer directly under the authority of the commander of the regional group. The authorities initially include the geographical scope of one region or part of the area, which consists of:

A. Platoon leaders and includes:

- Platoon commander assisted by an officer or sergeant with the rank of associate at least.
- Administrative clerk.
- Justice Clerk
- Communications Center.

B - Regional stations: and, where appropriate, provided that each station is headed by a sergeant under the direct order authority of the commander of the platoon is considered the regional outpost of

regional smaller piece between the regional units. The regional authorities include the principle of one border town, or part of the city or village limits one or several neighboring villages.

C - Regional prisons: The head of each type or prison officer with the rank of staff sergeant, sergeant first at least.

Article 47: organizing groups driven on roads and emergency of the regional group, the command of both these groups officer directly under the authority of the commander of the regional group is assisted by an officer or sergeant with the rank of assistant at least. The regional authorities each include a regional scale specified for the regional group is organized as follows:

A - Group Manager, consisting of:

- The group is assisted as appropriate Nos. of officers.
- Administrative clerk.
- Records clerk.
- Operations room.
- Members of the group.

B - Emergency Group, consisting of:

- Group leaders and includes operations room.
- Patrols and reserve

Article 48: organize a platoon of beaches:

Organize a group of beaches, like the organization adopted a platoon of regional and provided for in paragraphs a web of Article 46 of this Decree, provided that the designation replaced the regional outposts cachets Navy. The regional authorities include the coast that extends along the borders of the region except the campus of ports and beaches located in the band said.

Article 49: organizing a group survey:

Organize a group survey, to escape regulation adopted platoon regional and laid in a paragraph of Article 46 of this Decree is composed of:

- Leader of the group.
- Members of the group

Article 50 Organize a group central prisons:

The central command of a prison group officer is a commander under the direct commander authority of the region's regional assisted a

Number of officers, consisting of:

A- The command of the group: organized along the lines of the regional group organizing the command provided for in a paragraph of Article 45 of this Decree.

B- Beirut Prisons: Add to all prisons, which are central prisons, according to what is a specific prison system applied at all times.

C- Factions of the Group: to take prisoners and secure the necessary services for the management of prisons.

Chapter III

Article 51: police chief tasks:

In addition to the common tasks of the leaders and heads of units set forth in Article 6 of this Decree, the chief of police follow up the following tasks:

- be careful of not making police groups on the implementation of their basic functions specified in laws and regulations enforced.
- Define the outlines of the leaders and heads of units in the areas of service while ensuring coordination among them.
- Monitoring the implementation of service with ensuring the survival of the permanent units have qualified and ready to carry out the tasks related, particularly those related to the consolidation of security and maintain order and ensure public safety.
- Overseeing the training and education of police officers to reach the required level of behavioral and cultural
- Seeking to identify the leaders and heads of units and directing them according to the interests of the service.
- Working within the limits of fitness to develop equipment and supplies and all the necessary equipment disposal units to perform its functions fully.

Article 52: the functions of the police chief assistant.

A- First Assistant functions:

- Acting as police chief in the case of this latest interruption in service for any reason »exercises

In this case all the functions and authorities of the police chief exception Command Council membership to participate in internal security forces.

- manage the command branches and urges them to work with ensuring coordination among them.

- Express their views in all transactions flying to the commander of the police.

B - Tasks of second Assistant:

- Acting as first assistant in the event of absence of this latest report on the vinegar any case was.

- make the investigations and detections that are assigned by the commander of the police and the tasks specified by him personally and

Originally involved in the tasks assigned to the First Assistant.

Article 53: branches of the functions of command:

A - the respective functions of the many branches of the service and operations, management and administration, training and e:

The functions of these sections are similar to those of the people of Staff conformity with the nomenclature of anonymity, these branches and stipulated in Articles 12 and a 3, 14, 18 and 21 of this Decree.

B - Traffic Branch functions

This section will deal with all matters relating to traffic issues at a regional scale fixed for the regional police unit.

C. Branch functions of prisons:

This section will address the collection of administrative and financial matters relating to prisons and prisoners.

Article 54: Commander of the functions of the region:

The commander of the region primarily responsible for the implementation of all the services entrusted to the regional police throughout the region belong to him, especially in the implementation of the functions of administrative and judicial officer. So its public duties are a matter of the census is not limited to:

- Draw the outlines of heads of units in the areas of implementation of the service required of them, leaving them the freedom of initiative and attention to the details of implementation.

- Consolidation of information received by him and order, investment and give the orders and instructions necessary

- Intervene when necessary to address significant security incidents or when tracking dangerous criminals or when the prevalence of a certain type of crimes in the region.

- Verification of due process of regular services required in the

implementation of its units.

- Work to provide the units have the equipment and gear and supplies needed to ensure the maintenance and storage, according to the master, as well as maintenance of buildings occupied by these units.
- Maintain regular contact with the police chief and working with his immediate directives for each defect or negligence achieved it.
- . Maintain close relations with the military authorities and administrative authorities and a mechanism concerned.

Article 55: assistant commander of the functions of the region.

That the functions of assistant commander of the region are similar to the specific functions of assistant police chief set forth in Article 52 of this Decree

Article 56: the functions of offices of the Regional Area Command

A - functions of the office, training, service, operations and management and mail:

- The functions of these offices are similar to those of the people of Staff matching names with the appellations of these sections provided for in Articles 12 and 13, 14 and 18 and a 2 of this Decree.

B- Maintenance Offices Tasks: This office, through his tech. Workshops Within technical possibilities available to him for maintenance of buildings, which groups the region, As well as maintenance of equipment, supplies and equipment set the disposal of these units except for communications equipment.

C- The functions of the Office of Sport Shooting and communications: This office to work on physical exercise imposed on all elements of units and oversee the implementation processes, as well as a different set fire to them and work on the survival of all means of telecommunications in the continuous work with subsequent maintenance and repair of communications equipment designed disposal units.

Article 57: Commander of the functions of the regional group:

The tasks of the leader of the regional group are:

- Department of Special Service and to identify objectives to be achieved while ensuring coordination between units of him.
- Monitoring the implementation of service and his subordinates will not come from the assets of order applied in this area. .

- Intervene directly in the management of the consolidation of security and maintaining order, which is important in terms of quality or in terms of the means used, or the geographic coverage area beyond the regional scope of the precise scope of one regional faction.
- Stay in close contact with his subordinates to find a way for the implementation of their respective service required of it and give the necessary instruction and guidance when necessary.
- Ensure that all the remaining units is poised to carry out the tasks required of them.
- The quest for survival equipment and gear and supplies provided by units up to him with savory work on securing maintenance when necessary, as well as construction and maintenance of buildings occupied by these units.

Article 58: the functions of the regional grouping is:

Special tasks assigned to the platoon commander is regional

A. In the case of platoon work as one group:

- Organizing and implementing the regional police services within the platoon.
- Knowledge of the region have full knowledge, including knowledge of the nature and behavior of its inhabitants and the extent affected by political, religious, economic and social while maintaining an atmosphere of trust and cooperation with them.
- Circulation of texts and orders received by the platoon and explained to the elements.
- Maintaining close ties with the administrative and judicial authorities.
- Ensure the consolidation of security and maintaining order, and giving orders to implement the necessary elements that whenever the need arises.

B - in case a piece of work platoon split into several regional stations: Subject to the provisions of paragraph a former platoon commander charged with the following regional:

- Control measures and actions taken by the heads of regional outposts in particular against security incidents, or when a particular type of rampant criminality in the region.
- Ensure the survival of regional outposts poised to implement the mandated services, in a manner that secures them access to various areas of greatest production.
- Supervising the activity of the regional posts, either by frequent

inspections and surprise checks in them or correspondence, especially the records and documents belonging service with fuller records organized by the elements.

- Do personally in his capacity as an officer Justice Assistant Attorney General extraordinary criminal investigations important in terms of education or in terms of the type of offence.
- Make every possible effort to make his subordinates have the advantages of firmness, impartiality and correctness of opinion and intellectual maturity.

Article 59: - Chairman of the functions of the regional outpost:

The tasks entrusted to the Head of the regional outpost are:

- Service organization and implementation of the tasks entrusted to the police within the regional piece of him. With the participation of some personal services.
- Knowledge of the region's full knowledge of him.
- Maintaining close ties with the administrative and judicial authorities.
- Mainstream legal and regulatory texts and orders received by the station and explained to the elements.
- Verification of the implementation of good service, and the means at its disposal like weapons, ammunition and machinery.
- Ensure the consolidation of security and maintaining order, and it has to this end and, when necessary, ask the platoon commander of the regional promotion material necessary for the sustenance of the elements in implementing this type of service.

Article 60: the functions of group leader walking (traffic):

The tasks entrusted to the leader of a group walk are:

A. Regulate the traffic and this:

In provincial centres in major cities by the multiplicity of a Decree in accordance with Article 232 of the Act regulating internal security forces.

- On the entire network of public roads within the territorial scope of the group except for roads located within the villages and towns not considered extending great.
- B - Ensuring public safety and
 - A traffic control - regularly and permanently, taking into account the conditions of roads and daily changes therein.

- Directing road users continuous guidance and through tips and guidelines to ensure the safety and ethics of traffic especially in terms of contributing to control drivers and disciplinary mechanisms to arrest aspects of the roads as well as barriers that impede traffic.
- Maintaining the consequences of traffic accidents and provide first aid to those infected and help drivers within the possibilities available to repair the faults that have occurred on mechanisms in an emergency.
- Organizing records in accordance with the master.

Article 91: Commander of the functions of a group of emergency:

The tasks entrusted to the leader of a group of emergency are:

- Secure backing to groups of regional police and
- Fired continuous patrols day and night to deter any action breach of security or for the Suppression of each flagrant delicate or to respond to every request from citizens for survival.
- Maintaining a reserve forces remain ready to intervene at every emergency request for the consolidation of security and keeping public order and mother.
- Subscribe to security operations related to the consolidation of security and maintaining order »and chase and chase the criminals, rescue and relief operations, particularly during natural disasters.

Article 62: Commander of the functions of the Group survey:

The tasks entrusted to the leader of the survey group with elements acting topics are:

- Survey and collect information relating to maximum administrative officer.
- This information is clarified as soon as possible conduct a regional commander of the region.
- Survey information on the internal security forces and civilian candidates to volunteer or work at the Internal Security Forces to identify rules and principles that these surveys instructions from the Director-General.

Article 63: Commander of the tasks set beaches:

The tasks entrusted to the leader of a group of beaches with elements of it are:

- Implementation of maritime laws and regulations and working to

tolerate its provisions by ships and boats located territorial waters

- Combat crimes at sea, especially smuggling.
- Pollution Control sea and quick move to prevent its occurrence, particularly pollution from waste plants.
- Relief boats sank or threatened stricken or those exposed to acts of piracy and that the vulnerabilities of the possibilities available.
- Ensure the security and safety of citizens places on the swimming beaches.
- Suppression of infringements on public property, marine and prevent sea bridge, contrary to regulations applied.
- Combating extract sand and gravel from public property without permits Marine advance.

Article: 64: Commander of the tasks set central prisons.

Limited functions of the commander of a group of central prison to prison management in Beirut and those away from Beirut and marked in accordance with regulations in force, central prisons E, as well as secure custody and prevent any encroachment upon and take precautionary without establishing any attempt for them. This is in addition to special tasks specified in the applicable regulatory texts, particularly the provisions on prison systems.

The functions of the heads of units for this group is similar to the specific functions of the heads of the units of the regional companies that are laid down in previous Articles of this Chapter , taking into account the nature of the services required from each of them.

Part VI

The Force traffic unit

Chapter I Organization Force traffic

Article 65. Organizing a Force walking:

The scope of the work unit Force traffic all Lebanese territory, which consists of

A - traffic and Force command includes:

- Commander of forces assisted by traffic officers designated First Assistant and Assistant II to pass a Force leader.
- . Branches of command, namely:
 - Accouterments Branch.
 - Branch of service and operations and had an operation room.
 - Branch Administration.
 - Branch training.

- Branch mail.

B - regiment central passage.

C. Batches over regional.

D - Rapid Intervention Brigade.

Organize branches of command in the Force lines of traffic regulation adopted similar branch command in the regional police unit as stipulated in Article 42 of this Decree.

Article 66: Organization regiment walking:

Regiment composed traffic, whether central or regional:

A. Brigade Headquarters walking: organized along the lines of regulation adopted for the command of the regional police unit and: stipulated in a paragraph of Article 43 of this Decree.

B. Groups traffic management: Each group includes a Nos. of factions, in addition to the platoon of specialized heavy weapons and anti-armour weapons.

C - A group Armored: The factions armored vehicles.

D - A group of logistics: the indivisible to:

- Platoon Catering and includes processing, nutrition and transportation. -

A set of equipment and technical concerns include mechanisms for weapons, supplies and communications equipment.

- Medical Group.

Article 67: Organization of the Rapid Intervention Regiment:

Rapid Intervention Brigade consists of:

A - commander of the regiment: organized along the lines of regulation adopted for the command of the regional police unit And set out in a paragraph of Article 43 of this Decree.

B - Platoon Group: specialized anti-riot and terrorism in addition to the platoon boats freely and a squadron of helicopters.

Article 68. . Link and the authorities of heads of units passing the command of each batch of traffic and rapid intervention brigade officer commander under the direct authority of the commander of the unit passer forces, have regarding the granting rewards group leaders authorities specified in the law organizing internal security forces.

The command of both groups passing armored vehicles and a logistics group, and those of the rapid intervention brigade officer

under the direct authority of the commander of the regiment, and the leaders of both factions of the commander of those units directly under the authority of the commander of the group.

The leader of supply comprised of each platoon is an officer.

Chapter II

Functions and traffic units

Article 69: the functions of Force traffic

In accordance with paragraph 5 of Article 6 of the Act regulating internal security forces are Force traffic Reserve General of the Internal Security Forces, and assigns the task to stand by and support the rest of the units in order to consolidate security and keeping order and hunting down the wanted persons to justice and implementation of all tasks related to the internal security forces In all Lebanese territory when it can not on its own contingent of complete control of the situation in their areas.

Article 70. The functions of a Force leader crashes.

In addition to the common tasks of the leaders and heads of units set forth in Article 6 of this Decree, entrusted to pass a Force leader following tasks:

- Careful to keep all units have qualified and ready to intervene immediately in any region of the Lebanese territory to support the regional units.
- Overseeing the training element of unity are well up to the high level of art practice riot control and chase Scamps.
- Working within the limits of his authorities to develop sophisticated technical means necessary including weapons disposal units him.
- Took command of security operations personally when circumstances require the intervention of its units, which more than two battalions.

Article 70: the functions of assistant commander of the forces walking:

A - functions First Assistant

The tasks of the first assistant to the commander of the traffic is similar to those of the first assistant to the commander of the police set out in a paragraph of Article 72 of this Decree.

B - tasks Assistant II:

Assistant II exercised the same tasks set for the second assistant to the commander of the police set out in paragraph b of Article 52 of this Decree in addition to the following:

- . Personally supervise the security operations, and so on the orders of the commander of the traffic.
- Control Operations units with training components to ensure diversification of these operations in normal conditions and multiple different places.
- Permanently verify the validity of equipment and supplies and the effectiveness of weapons supplied by groups of Force traffic.

Article 71: branches of the functions of command:

The tasks of the branches of command in the unit is Force traffic similar to those of the people of Staff matching names with such appellations run up and stipulated in Articles 12 and 13, 14, 18 and 21 are present Decree.

Article 73: the functions of leaders and heads of units passage:

In addition to the common tasks of the leaders and heads of units set forth in Article 6 of this Decree, including the leaders and heads of units passing the command of groups who are purely military, therefore each of them to apply himself to train and rehabilitate its components for the important role assigned to you, especially in terms of:

- Development of physical abilities remain ready to combat efficiency enables them to control speeds at various incidents of insecurity they may face.
- Strengthen and enhance their sense of intolerance of the unit to which they belong, and on the spirit of individual and train them to work as groups and not as noncommissioned officers .
- Interest in young volunteers are especially so with their whole group to which they belong.
- To maintain strict discipline, fair and stay in constant contact with them and address all problems that may be exposed.

Article 74: tasks - batch rapid intervention:

The regiment rapid intervention units in the internal security forces working for all units in all Lebanese territories to carry out security tasks sensitive and delicate that require extensive experience in

military, which is used particularly in the implementation of tasks relating to the riots sector.

Article 75: places units stationed walking:

Both are stationed command Force traffic and traffic regiment central and rapid intervention in the Beirut suburbs, or in one E The rest of regimental traffic distributed to the provincial centres and in other areas determined by the Director-General.

Article 76: Conditions for use of units passage:

Prohibits the use of any group in the passage of the consolidation of security and order if the less than one platoon as a platoon traffic is the smallest operational group can be used not this type of operation.

Title VII

Chapter I Organization of Beirut Police

Article 77: Organization of Beirut Police

Include the authorities of regional police unit Beirut city of Beirut, and includes - all operating units except those which are associated wholly or partly in one of the other units consisting

A. Police Command, comprising Beirut

- Police Commander Beirut designated Assistant Commander is assisted by the first and second assistant police chief for Beirut. .

Branches of command, namely:

- Accouterments Branch .

- Branch of service and operations and branch administration follows

- Branch training.

- Traffic Affairs Branch.

- Mail Branch.

B - Regional groups

C - Walking group.

D - Regiment emergency.

E - Beaches group.

And - survey group.

Article 78: Organization Branch command

Organize branches of the command in Beirut police unit similar to organize branches of command in the police unit set forth in Article 42 of this Decree.

Article 79. Organizing regional group:

The command of the regional group in Beirut, a police officer, commander under the direct authority of the Beirut police chief assisted by Nos. of officers, either regional authorities include part of the city of Beirut, which consists of:

- Office of service and operations and tracking operations room and a communications centre.
- Post Office.

B- Factions regional group:

Include regional authorities each platoon is part of a regional scale specified for the regional group affiliated with the faction. They include:

- . Platoon commander assisted by Commander
- Administrative clerk.
- Justice Clerk.
- Communications Center.
- Elements platoon.

Article 80: organizing a group walking:

The traffic officer leading a group commander under the direct authority of the Beirut police chief assisted by Nos. of officers. The regional authorities include the city of Beirut E is composed of:

A - the command group walking:

Organized along the lines adopted regulation to lead the regional group in Beirut provided local police in a paragraph of Article 79 of this Decree.

- Groups passage:
Specify the Accouterments depending on the Nos. of regional groups Beirut police unit is composed of:
- Leader of the group assisted Nos. of officers. .
- Administrative clerk.
- Records of traffic
- Operation room.
- Elements of the group.

Article 81: Organization batch of emergency.

The emergency command regiment commander under the direct authority of the commander of the Beirut police officers assisted by Nos. of assistants. The regional scope includes the city of Beirut,

which is composed of:

A - Emergency Brigade Headquarters: organized along the lines of regulation adopted for the command of the regional police unit set out in a paragraph of Article 43 of this Decree.

B - Security groups: the rest of the officers and officers and people between jobs inside the barracks It consists of Nos. of factions, the command of each officer, assisted by Nos. of officers, the commander of each group is linked directly regiment commander of emergency.

C - Platoon mechanisms: be under the command of an officer assisted by Nos. of officers and personnel specialists work of maintenance and repair mechanisms, including armored vehicles, a platoon commander mechanisms subject to the authority of the immediate emergency regiment commander.

D - factions of armored vehicles: be under the command of an officer under the direct authority of the commander of the regiment emergency either faction leaders armored vehicles officer, will assume the presidency under the direct authority of the officer in charge of the group factions armored vehicles.

- Reserve force: includes Nos. of faction leaders will each platoon officer directly under the authority of the commander of the force reserve officer, which is a leading directly to the regiment commander of emergency.

Article 82: organize a platoon of beaches:

The group leaders beaches officer directly under the authority of the commander of the Beirut police officer, assisted by either the regional authorities to this group include seashore route from the northern borders of Beirut to its southern border, which is regulated in accordance with the organization adopted a set of beaches in the regional police unit set forth in Article 48 of this Decree .

Article 83: Organization of the survey group:

The survey group leaders officer directly under the authority of the commander of the Beirut police officer, assisted by either the regional authorities to this group include the city of Beirut and consists of:

- Leader of the group.
- Elements of the group.

Chapter II

The functions of police units in Beirut:

Article 84: the functions of the Beirut police chief and entrusted him:
The functions of the Beirut police chief is similar to the tasks listed for the regional police chief set forth in Article 51 of this Decree and the functions of each of his assistants were similar to the specific functions of assistant regional police commander set forth in Article of this Decree.

Article 85 tasks Branch police command in Beirut:

The functions of the branches of command Beirut police are similar to those branches of command in the regional police unit set forth in Article 53 of this Decree.

Article 86: the functions of the leaders of the regional units in the Beirut police:

The functions of the commander of the regional group police Beirut is similar to the functions of specific regions of the leaders and leaders of regional groups and the regional police unit set forth Articles 54 and 57 of this Decree.

The functions of the regional faction leaders in Beirut, police are similar to the tasks set for the regional group of faction leaders in the regional police unit set forth in a paragraph of Article 58 of this Decree.

Article 87: Commander of the tasks set Traffic

The tasks of the leader of a group walk in the Beirut police are similar to the tasks set for the leaders of groups of traffic police unit in the regional and set forth in Article 60 of this Decree.

Article 88: Commander of the functions of emergency:

The regiment commander of the functions of emergency police in Beirut is similar to the tasks set for the leaders of groups of emergency police unit set forth in Article 61 of this Decree.

Article 89: - leaders of factions of the functions of armored vehicles and a platoon mechanisms:

Limited functions of the leaders of factions, groups of armored vehicles supported by a set of emergency and other units of the Beirut police unit, in addition to the actual processes consolidating their security and policing issues.

The functions of a platoon commander mechanisms will be restricted

B - Office of explosives.

C - Office of tracing.

Organizes each of these offices along the lines of regulation approved for the offices of the Criminal Investigations Department Assembly provided for in Article 95 of this Decree.

Article 102: the organization of the police department of tourism:

This section is headed by an officer commander under the direct authority of the Judicial Police Commander. The regional authorities include all Lebanese territory, which consists of:

A - the presidency of the section: organize similar regulation adopted

- The collection of documents belonging to persons or on issues where he remained unknown perpetrator or science and received from various units and from the judiciary, or the rest of the public administrations in order to control these people or deportation, or search them or prevent them from traveling, according to the master.

B - With regard to the Office of Investigations:

- Graduates of the Institute of certificates granted by the Directorate General Bearing models.
- Propose the dissolution of contracts volunteered sergeants and training personnel, especially in the case to verify the eligibility of non-member to serve in internal security forces or sediment for the second time at the end of exams sessions upbringing.

Article 137: the functions of the Chief of Training:

Article 138: Responsibilities chief research and lessons:

The head of the research and lessons officer Commander at least directly under the authority of the commander of the Institute assisted by an officer called the assistant chief of research and lessons. The tasks assigned to this section are the following:

- . Research and preparation of lessons aimed at raising the level of training and development of the means adopted.
- Follow the scientific development assistance in training and propose the adoption of appropriate action.
- Investigation of the problems and difficulties for the trainers, practitioners and elaborate appropriate solutions to them.

Article 135: Commander of the functions of the Faculty of officers

The Command College officers officer Commander at least directly under the authority of the commander of the Institute assisted as appropriate Nos. of officers and civilian professors. The tasks assigned to this college are:

- Rearing officers graduated from the Military Academy, prepared and rehabilitation service for the internal security forces.
- Conducting sessions severity of some officers of specialists.
- . Candidates prepare officers for promotion.
- Rehabilitation sergeants candidates for promotion to the rank of lieutenant.

Article 140 tasks considered leaders of the Institute:

Article 141: the use of professors and lecturers civilians:

Article 144: the functions of Head of the Department of Social Services:

Ensuring the implementation of regulations for managing the funds and institutions.

Article 145: the functions of assistant head the Department of Social Services:

The functions of each of the assistants to head the Department of Social Services is similar to the specific functions of assistant head of the Central Administration set forth in Article 28 of this Decree.

Article 146: the functions of the heads of the funds:

The functions of each of the heads of the funds referred to in Article 142 of this Decree in the special regulations issued Decrees in accordance with paragraph / 3 / Article 6 of the Act regulating internal security forces.

Article 147: the magazine internal security forces:

To be determined on instructions from the Director General to organize the Department of Internal Security Forces Journal and assets in both offices, and after an opinion poll Head of the Department of Social Services.

Article 148: the use of the owners of experiences:

Can and in accordance with regulations in force using the required Nos. of owners of civilian expertise and specialists, in all units of the Department of Social Services.

Article 149:

The Director-General, at the suggestion of the commander of the unit concerned, and for reasons that do not have a permanent character, as ordered following the establishment of temporary centres to ensure effective control in any region of Lebanon:

- Temporary centers when the circumstances which ruled resort to this measure unexpectedly replicated at specific times for far longer periods.
- Centers when seasonal conditions which ruled that recur in certain

Article 150:

Taking into account the provisions of the law on internal security forces, specifying the instructions of the Director-General texts applied the provisions of this Decree especially:

- How to transmit judicial investigations of the regional units to groups of the judicial police.
- Identifying regional units with the appointment of a regional scale each.

Article 151:

Both leaders regions and regimental commanders referred to in this Decree, in terms of granting rewards authorities of regional leaders set them in the law organizing internal security forces, either in terms of their authorities to impose penalties specified by law is referred to in the preceding paragraph.

Article 152:

Repeal all provisions and texts dissenting and conflicting with the provisions of this Decree, especially the provisions of Decree No. 3844 date 21/4/1960.
